How do we collect information from you?

We may collect information about you when you interact with us and knowingly provide us with personal information. For example, when you contact AlgarvianRoots regarding our activities, send or receive information, engage with our social media. In addition, we may collect anonymous information about the services you use and how you use them. For example, when you watch a video on YouTube, visit our website or engage with social media. We may also collect information about you from publicly available sources.

What information do we collect?

The information we might collect includes your name, address, email address, IP address and data regarding the webpages you have accessed and when. If you make a tour booking or purchase a product from us, your card information is not held by us, but is collected by our third party payment processors (such as PayPal or Stripe) who specialize in the secure online capture and processing of credit/debit card transactions.

How do we use that information?

We may use your information to:

- ♣ Provide you with information about our work that you have requested or which we feel may be of interest to you. This may include information about campaigns, appeals, events, promotions of any associated goods and services and general updates of our work.
- ♣ Contact you where you have been identified as a contact person for an organization, such as a school or a company.
- ♣ Answer your enquiries or seek your views about a service we provide, through voluntary surveys or research.
- ♣ Process a job, volunteer or internship application.

Who has access to your information?

We do not sell or rent your information to third parties, nor do we share it with them for marketing purposes. We may pass your information to our third party service providers and other associated organizations for the purposes of completing tasks and providing services to you on our behalf (for example, to process a payment). However, when we use third party service providers, we disclose only the personal information that is necessary to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own direct marketing purposes. The only exception to this rule is if we are required to release your information by law, for example by a court order or for the purposes of preventing fraud or other crime.

How do we protect your personal information?

When you give us personal information, we take appropriate physical, electronic and managerial steps to ensure that it is kept secure, accurate and up-to-date.

Although we use appropriate security measures once we have received your personal information, the transmission of information over the internet is

never completely secure. We do our best to protect personal information, but we cannot guarantee the security of information transmitted to our website or over email, so any transmission is at the user's own risk.

However, any sensitive information (such as credit or debit card details) is encrypted and protected using SSL and other industry standard measures, to provide an additional level of security.

As well as this, any personal identifiable information can only be accessed AlgarvianRoots staff on a 'need to know' basis and held in strict confidence.
