General terms

This site belongs and is operated by the company **Silêncio Místico Unipessoal Lda.**, owner of the registered brand AlgarvianRoots, representative of the tourism animation offers. This website offers visitors the possibility to make reservations and the consequent payment for AlgarvianRoots tourism services.

When purchasing a service/product, you agree that: (1st) you are responsible for reading the complete information about the service/product before committing to purchase it: (2nd) you accept a legally binding contract to purchase a service/product when you complete the payment process.

The prices we charge for our services/products are listed on the website. We reserve the right to change our displayed product/service prices at any time and correct pricing errors that may inadvertently occur.

We may, without notice, change the services; stop providing the services or any features of the services we offer; or create limits for services. We may permanently or temporarily terminate or suspend access to the Services without notice and liability for any reason or no reason.



Users

To purchase our services/products, you must be at least 18 years old and possess the legal authority, right and freedom to participate in these services.

Booking

Booking an activity is carried out between the customer and AlgarvianRoots or between the customer and an affiliated reseller.

Our activities can be booked through our website, by phone or by email.

The cut off time for bookings is 72 hours for full-day activities or for workshops with local artists. The cut off time of reservations for guided hikes is 48 hours.

After the stipulated cut off time, reservations can only be made by telephone.

Payment is made directly on the website using **Stripe** technology through the **Pluralo** platform.

Payment for activities is made in EURO.

Reservations made through any other travel agency are decided and dealt with between the travel agency in charge for the booking and the customer, not with AlgarvianRoots.

Cancellation, return and refund policy

(1) Cancellation of the activity by the customer

Cancellation of the experience by the customer up to 48 hours before the start of the service: the customer is refunded with the full amount of the purchase.

Cancellation of the experience by the customer less than 48 hours before the start of the service: the customer doesn't receive a refund.

(2) No show

If the client(s) does not show up on the date, time and place of departure of the service indicated on the booking confirmation or subsequent communication, the client will not receive a refund.



(3) Cancellation of services by AlgarvianRoots

All activities have a minimum number of participants, depending on the activity. AlgarvianRoots reserves the right to cancel a service in case there is not the minimum number of participants, in case of adverse weather conditions, in case of a situation that jeopardizes the safety of the service (for example: forest fire, thunderstorm, storm), mechanical problem in the means of transport that makes it impossible to carry out the activity or other unforeseen circumstances of force majeure.

In case of cancellation by AlgarvianRoots, the customer has the option of choosing another date or receiving a 100% refund.
